Um tribunal na Rússia disse nesta segunda-feira que o julgamento de espionagem do jornalista americano Evan Gershkovich começará semana passada e os procedimentos serão realizados a portas fechadas.

A primeira audiência, marcada para 26 de junho virá quase 15 meses depois que o Sr. Gershkovich foi preso por agentes da segurança na cidade russa do Yekaterinburg (cerca dos 900 milhas a leste) onabet 1mg Moscou e após passar mais um ano numa prisão alta-segurança no país é provável ser transferido novamente ao julgamento pelo Wall Street Journal s vezes chamado "The WSJ".

Gershkovich, que trabalhou na Rússia como jornalista onabet 1mg várias publicações por mais de cinco anos antes da onabet 1mg prisão e seu empregador negaram as acusações contra ele. O Departamento do Estado designou o Sr gershkkovitch "erradamente preso", a qual efetivamente obriga-o para trabalhar pela libertação segura dos mesmos;

O anúncio de uma data experimental representa um passo significativo no caso legal do Sr. Gershkovich, que tem continuado onabet 1mg paralelo com as negociações entre os serviços russos e americanos para possível troca ”.

As autoridades russas sugeriram que poderiam estar abertas a uma troca de prisioneiros pelo Sr. Gershkovich, mas somente depois do veredicto ser proferido onabet 1mg seu caso: um julgamento por espionagem geralmente leva cerca quatro meses na Rússia e pode levar até 1 ano para acontecer o crime; segundo advogados envolvidos nesses casos?

Na semana passada, os promotores russos disseram que tinham finalizado a acusação de espionagem contra o Sr. Gershkovich e "sob instruções da CIA" usando métodos conspiratórios meticulosos", ele estava coletando informações secretas sobre uma fábrica na região Sverdlovsk para produzir tanques ou outras armas

A declaração dos promotores foi a primeira vez que representantes do Estado russo revelaram detalhes das acusações contra o Sr. Gershkovich, mas faltavam evidências para apoiar as alegações de acusação

Realizado a portas fechadas, o julgamento é improvável que lançar mais luz sobre seu caso. O julgamento será ouvido por Andrei N. Mineev, juiz do tribunal regional de Sverdlovsk onabet 1mg Yekaterinburg (Iekaterinburgo), segundo um comunicado da corte perante o Tribunal Nacional e numa entrevista a 2024 com uma página noticiosa russa na Internet que disse ter entregue apenas quatro absolvições durante décadas; se condenado ao crime ele pode ser preso até 20 anos depois disso mesmo!

O Wall Street Journal emitiu um comunicado na semana passada prevendo uma "tentativa de fraude".

Gershkovich é um dos vários cidadãos americanos que foram detidos na Rússia nos últimos anos, e seu caso levantou temores de o Kremlin está buscando usar os norte-americanos como moeda para negociar com russos mantidos no Ocidente.

Outros americanos detidos na Rússia incluem Paul Whelan, veterano da Marinha dos EUA; Alsu

Kurmashaseva editor que trabalha para a Radio Free Europe / Rádio Liberdade e Marc Fogel (um professor americano no Anglo-American School onabet 1mg Moscou), condenado à 14 anos de prisão por contrabando. Na semana passada um tribunal russo condenou Yuri Malev - cidadão nacional russa ou americana – aos três meses depois do massacre pela Ucrânia após o assassinato pelo governo ucraniano
