## **Oficiales de Turks y Caicos rechazan comentarios de legisladores estadounidenses**

Oficiales de Turks y Caicos han condenado los comentarios de legisladores estadounidenses que viajaron a las islas la semana pasada para presionar por la liberación de ciudadanos estadounidenses arrestados allí, quienes podrían enfrentar sentencias de hasta 12 años.

En un discurso en la Asamblea Legislativa, el Primer Ministro Washington Misick dijo: "Las acusaciones del congresista (Guy Reschenthaler) contra el gobierno y el pueblo de las Islas Turcas y Caicos no son más que mentiras diabólicas".

Una delegación del Congreso de EE. UU. viajó a las islas para reunirse con funcionarios esta semana y presionar por la liberación de los estadounidenses detenidos acusados de poseer municiones.

Tres de los estadounidenses - Michael Lee Evans, Bryan Hagerich y Tyler Wenrich - se han declarado culpables de poseer municiones mientras viajaban en Islas Turcas y Caicos, según el gobierno de Islas Turcas y Caicos, con Hagerich programado para ser sentenciado el viernes.

Una cuarta persona, Ryan Tyler Watson, comparecerá en la corte el 7 de junio. Una quinta persona, Sharitta Shinese Grier, fue arrestada la semana pasada y permanece bajo custodia hasta su próxima comparecencia en julio.

### **Demandan libertad inmediata**

Uno de los legisladores estadounidenses, el senador Markwayne Mullin, dijo en un comunicado el lunes: "Desafortunadamente, a pesar de nuestra disposición a trabajar con los funcionarios de Islas Turcas y Caicos para llevar a nuestros constituyentes a casa, no pudimos encontrar un camino a seguir hoy".

El congresista Reschenthaler dijo a bet365 365 que quiere ver una "resolución aquí donde los estadounidenses no reciban tiempo en la cárcel. Deben dárseles tiempo servido y enviarlos a casa a los Estados Unidos".

"Fueron errores inocentes. Cualquier otra nación manejaría esto con una multa y enviando a esa persona de regreso al país de origen. Aquí, eso no está sucediendo", dijo, agregando que "La prisión en Islas Turcas y Caicos ha sido señalada por la ONU por preocupaciones humanitarias".

El congresista dijo que la sentencia mínima de 12 años que conllevan los cargos de municiones es "completamente inaceptable" y que los estadounidenses trajeron las municiones sin saberlo.

### **Valoran relación con EE. UU.**

La gobernadora de Islas Turcas y Caicos, Dileeni Daniel-Selvaratna, dijo en un comunicado el miércoles que Islas Turcas y Caicos valora su relación con EE. UU. y que los dos países trabajan en "fuerte asociación para abordar las amenazas compartidas en la región".

El comunicado dijo que Islas Turcas y Caicos no tiene como objetivo a los ciudadanos estadounidenses y calificó los comentarios de Reschenthaler sobre el viaje del congresional delegación a las islas para reunirse con funcionarios "altamente lamentables".

"Su caracterización de nuestra reunión no es una que reconocemos", dijo el comunicado.

"Nuestras discusiones fueron profesionales y respetuosas con un enfoque en aclarar la posición legal y el bienestar de los individuos", dijo el comunicado.

La gobernadora agregó que la sentencia mínima obligatoria de 12 años por posesión de armas

de fuego y/o municiones está en vigor para proteger a los que están en las islas y que la ley brinda discreción en "circunstancias excepcionales" para que el juez imponga una sentencia reducida.

No ha recibido ningún ciudadano estadounidense la sentencia de 12 años hasta la fecha, según el comunicado.

## **El premier: "La ley debe aplicarse uniformemente"**

El premier Misick dijo que de un total de 195 personas sentenciadas por delitos relacionados con armas de fuego en los últimos seis años, solo siete fueron ciudadanos estadounidenses. El premier dijo el jueves que no debe darse un trato especial a ningún grupo.

"La ley debe aplicarse uniformemente", dijo el premier.

Mientras que EE. UU. y Islas Turcas y Caicos trabajan juntos en la lucha contra las drogas narcóticas, el terrorismo y el lavado de dinero, "nuestras leyes y procesos no son congruentes", dijo el premier. "Somos una soberanía separada. Respetamos las leyes de EE. UU. y nunca pensaremos en interferir en su operación".

El gobierno de Islas Turcas y Caicos, dijo el premier, tomará "acciones decisivas y comprehensivas para preservar la seguridad y la seguridad de nuestra nación", agregando que el país no fabrica armas de fuego o municiones, pero el número de armas de fuego que encuentran su camino a las islas ha aumentado.

El miembro designado de la oposición, Alvin Garland, expresó su preocupación por los ciudadanos estadounidenses que han sido arrestados en Islas Turcas y Caicos por poseer municiones en los últimos seis meses.

Garland dijo que el gobernador tiene razón en no interferir con los casos judiciales en curso para adherirse a la separación de poderes, pero agregó que cree que la mayoría, si no todos, de los casos que involucran a turistas estadounidenses caerán en la "categoría de circunstancias excepcionales" y las sentencias podrían ser más cortas que la sentencia mínima obligatoria de 12 años.
