# Estadounidense acusado de poseer municiones en Islas Turcas y Caicos recibirá sentencia suspendida

Un ciudadano estadounidense que fue acusado de poseer municiones en Islas Turcas y Caicos será liberado después de que un tribunal impusiera una sentencia suspendida y le impusiera una multa de R\$2,000.

Ryan Tyler Watson de Oklahoma se declaró culpable el mes pasado de poseer cuatro rondas de municiones, según un portavoz del gobierno de Islas Turcas y Caicos. Desde entonces, había sido puesto en libertad bajo fianza y se le ordenó quedarse en las islas mientras esperaba la sentencia.

El viernes, Watson recibió una sentencia suspendida de 13 semanas y una multa de R\$2,000 – R\$500 por bala, según un portavoz del Tribunal Supremo de las Islas Turcas y Caicos.

Watson no necesitará cumplir la sentencia de 13 semanas "siempre que no cometa delitos y mantenga la paz en el TCI dentro de los próximos 9 meses", dijo el portavoz del tribunal. Watson "ahora está autorizado a partir ... ya que ha sido absuelto por la justicia en el TCI."

Watson se espera que regrese a la ciudad de Oklahoma el viernes por la noche, según Jonathan Franks, portavoz de Bring Our Families Home.

"Pagaremos en breve, partiremos del TCI y anticipamos estar en OKC esta noche", publicó Franks desde el tribunal.

Watson visitaba Turcas y Caicos con su esposa en abril para celebrar los 40 cumpleaños de varios amigos. Sin embargo, introducir armas de fuego o municiones en Turcas y Caicos sin permiso previo de la policía está "estrictamente prohibido".

El Territorio Británico de Ultramar no fabrica armas ni municiones, pero el número de armas de fuego que llegan a las islas ha aumentado, según el Primer Ministro de Turcas y Caicos, C. Washington Misick, en mayo.

"En las Islas Turcas y Caicos, la ley es clara y se aplica a todos por igual, sin excepción", dijo Misick en un comunicado el mes pasado.

Las Islas Turcas y Caicos recientemente revisaron parte de su ley de armas de fuego después de que un grupo bipartidista de miembros del Congreso de EE. UU. viajara a las islas al sureste de las Bahamas y solicitara a los funcionarios que retiraran los cargos contra cinco estadounidenses a los que dijeron que "inadvertidamente" tenían municiones en su equipaje.

La nueva enmienda aclara cuándo los tribunales pueden imponer sentencias por delitos relacionados con armas de fuego, los tribunales tienen discreción para imponer una multa, una sentencia de prisión o una mezcla de ambas en circunstancias excepcionales.

Anteriormente, la ley exigía que los tribunales impusieran
