Donald Trump acusa al Departamento de Justicia de estar dispuesto a matarlo

En las redes sociales y en un correo electrónico de recaudación de fondos del martes, Donald Trump planteó una preocupante inquietud. El Departamento de Justicia, dijo, estaba listo para matarlo.

La distorsión salvaje se produjo en el contexto del juicio por soborno de Trump en Nueva York y ante el temor de un aumento de la violencia política alrededor de las próximas elecciones presidenciales, predominantemente desde la extrema derecha. Los comentarios consolidan una imagen invertida que Trump y sus aliados han pintado, en la que un patriótico Trump se enfrenta a enemigos antidemocráticos de las profundidades del estado.

El correo electrónico de campaña de Trump decía: "Saben que solo están deseando hacer lo impensable". El ex presidente firmó el correo electrónico. "Joe Biden estaba cargado y listo para sacarme y poner en peligro a mi familia".

En su sitio web de redes sociales, Truth Social, Trump repitió la afirmación. "La DoJ de Joe Biden corrupto, en su allanamiento ilegal e inconstitucional de Mar-a-Lago, AUTORIZÓ AL FBI A UTILIZAR FUERZA LETAL", afirmó.

Trump parecía referirse a la orden de registro y allanamiento ejecutada en agosto de 2024, cuando los agentes encubiertos del FBI allanaron la mansión de Trump en Mar-a-Lago en busca de documentos clasificados que Trump había supuestamente se negó a entregar al gobierno.

Una presentación judicial de mayo de 2024 de los abogados de Trump, bajo una sección titulada "El allanamiento ilegal", cita una línea en la orden de registro.

El Orden contenía una "Declaración de Política" sobre "Uso de Fuerza Mortal", que establecía, por ejemplo, "Los agentes de aplicación de la ley del Departamento de Justicia pueden usar fuerza mortal cuando sea necesario", escribieron los abogados que representan a Trump.

El lenguaje citado en la presentación parece haber sido tomado de la política del DOJ que rige el

uso de la fuerza en la ejecución de órdenes de registro. El texto completo de la política lee: Los agentes de aplicación de la ley y los agentes correccionales del Departamento de Justicia pueden usar fuerza mortal solo cuando sea necesario, es decir, cuando el agente tiene una creencia razonable de que el sujeto de tal fuerza representa un peligro inminente de muerte o lesiones corporales graves para el agente o para otra persona.

La agencia ejecutó la orden de registro para buscar el hogar de Trump en Florida mientras Trump estaba en Nueva York y supuestamente se comunicó con los agentes del Servicio Secreto presentes para garantizar una operación sin problemas.

En un comunicado, el FBI describió el lenguaje como "una declaración de política estándar que limita el uso de la fuerza mortal. Nadie ordenó pasos adicionales y no hubo desviación de la norma en este asunto".

El Washington Post ha informado previamente que los agentes del FBI eligieron un día para el allanamiento cuando Trump no estaría en Mar-a-Lago y le informaron al Servicio Secreto con anticipación.

Pero las declaraciones de Trump sobre el tema han desatado una histeria. Christina Bobb, abogada del ex presidente que firmó documentos antes de la búsqueda que afirmaban que Trump había cumplido con la citación para documentos, reaccionó con hiperbol ...
