Aileen Cannon, a judge in Florida who was criticized for dealing with accusations of confidential documents against Donald Trump? ignored the advice of more experienced colleagues to refuse and pass it to another lawyer.

Two senior judges on the Florida bench asked Cannon to step back when she was randomly assigned to supersport bet net wife supersport bet net June last, partially due to the fact of her being biased in favor of President Trump for the cause of her actions after the reports against him about keeping confidential documents from the government.

According to the New York Times, Cannon – who was named to the federal bench by Trump – rejected the advice and stayed in the supersport bet net case.

Since then, she issued a series of decisions widely criticized that had the effect of delaying the judicial hearing and the legal strategy for Trump was to keep his case under control until after the presidential elections supersport bet net November.

Her decisions have attracted the contempt of the ex-White House adviser, Ty Cobb, who this month described her as "dangerous and incendiary" and refused Cannon's request to grant a stay order by Smith against Donald Trump (Trump).

Smith had requested the order after the ex-president allegedly falsely, after having allegedly erroneously and falsely stated that an FBI was "blocked" from entering his family home when the officials entered his home in Mar-a-Lago (Marla) in search of documents in 2024. In reality: The attack was agreed upon in advance by the president's lawyers before the scheduled date when he would not be present; The attempt to persuade Cannon to step back was supposedly motivated by her actions after the FBI seized the documents – when she intervened on Trump's behalf after he had presented a process claiming the supersport bet net property was personal, naming a special master to review them before the prosecutors had a chance.

This decision was later reversed by the 11th appeals court supersport bet net Atlanta, which issued a rebuke of Cannon's judgment.

The argument that this episode was sufficient for Cannon to transmit the case would have been presented by Cecilia Altonaga, the chief judge of the southern district of Florida.

Another judge, not identified, would have placed a different line of reasoning for her – that it would be better to transfer the case to a lawyer closer to the court movement of the supersport bet net Miami region, where Trump had been indicted.

Since Cannon rejected the petitions to delay the case to another judge, a secure place to store the documents was built at the expense of taxpayers in the court where she presides supersport bet net Fort Pierce.
